ORDER


WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution viz. Naba Krushna Choudhury College of Teacher Education, Angul, Street No. Hakimpura, Vill-Angul, PO-Angul, Town/City-Angul, Dist-Angul, Odisha-759122 was granted recognition for conduct of B.Ed. Course of one year duration with an annual intake of 100 vide ERC order No. ERC/7-84.6(II).16/2008/10482 dated 14.03.2008 and vide order No. ERC/7-169.11.12.9/NCTE/B.Ed.-Addl. Intake/2014/24230 dated 24.02.2014 granted permission for additional Intake of 100, thus making the total intake of 200.

3. AND WHEREAS, the institution viz. Naba Krushna Choudhury College of Teacher Education, Angul, Street No. Hakimpura, Vill-Angul, PO-Angul, Town/City-Angul, Dist-Angul, Odisha-759122 has by affidavit dated 06.02.2015 consented to come under New Regulations 2014 and sought for Four Basic units in B.Ed. course, which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have four basic units of 50 students each with subject to fulfill following conditions namely,

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- III. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.


5. Now therefore, in the light of the above and in terms of Section 15(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition/permission to Naba Krushna Choudhury College of Teacher Education, Angul, Street No. Haklmpara, Vill-Angul, PO-Angul, Town/City-Angul, Dist-Angul, Odisha-759122 for conducting B.Ed. Programme of two years duration with an annual intake of 200 for four basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. If it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.




